Subject: Empanelment of Government Agencies for undertaking DDU-GKY Projects – reg.

It is stated that the following Government Organization is notified as empanelled for undertaking projects under Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDU-GKY):

2. The empanelled Government Agency shall comply with the criteria laid down in the Notification No. 40/2017 dated 24th July, 2017 which has further been modified vide Notification no.2/2021 dated 04th February, 2021.
3. The Government organization, after execution of MoU with the Ministry, may apply for DDUGKY PROJECTS (INCLUDING Himayat and Roshni) along with application fee and necessary documents in the online application at <https://erp.ddugky.info>. The State Governments concerned may exempt such proposals from requirement for qualitative appraisal and prioritize the proposals for consideration before its Project Approval Committee. Where an empanelled Government organization applies for a project as a consortium with any other organization which has not been notified as a Government Organization, then such proposal shall not be given the benefits of the said notification. The Government Agency notified above shall not outsource core activities of the program i.e., Training and Placement.
4. This notification is issued with the approval of Competent Authority and shall be effective from the date of issue of this notification.


