**B. Terms of Reference for the Committee:**

- The Committee may review and lay down the criteria for screening and selection of awardees.
- The Committee may co-opt experts/ external members with the approval of Chairperson
- The Committee shall take nominations for Awards through Rural Skills Division, MoRD
- The Committee shall give its recommendations to the Rural Skills Division, MoRD.
- The non-official Committee members shall be allowed Air travel and accommodation equal to entitlements prescribed by NRLPS for Experts.
- The Committee shall be provided administrative support by Rural Skills Division in MoRD.
- Tenure of Chairperson of the Committee shall be for a period of three years, extendable for further period(s) of one year by the Ministry.




