ORDER

Subject:- Constitution of Review Committee for evaluating and recommending Champion Employers for DDU-GKY program - reg.

The undersigned is directed to state that under Deen Dayal Updahyaya Grameen Kaushalya Yojana (DDU-GKY) a registered Project Implementing Agency (PIA) is eligible to become a Champion Employer for DDU-GKY projects on satisfaction of following conditions inter alia:

- i. PIA will provide wage employment to at least 10,000 candidates in the first two years.
 - ii. PIA will set up and brand its Skill Training Centers as “ - DDU-GKY Skills Academy”.
 - iii. PIA will allow its students an opportunity to get different levels of certification over a 2 year period with corresponding career progression so that in two years a simple trainee member may raise to the level of a supervisor.
2. Accordingly, in order to evaluate and recommend Champion Employers for DDU-GKY program Ministry of Rural Development has constituted a Review Committee for the purpose. The members of this committee will be as follows:

3. The Review Committee may decide the terms and criteria for evaluating and recommending Champion Employers, which may include taking a presentation by the PIA desirous of becoming a Champion Employer. The Review Committee may Nominate experts to advise the committee in its meeting.

4. The Review Committee shall be assisted by PfD, Rural Skills Division in all administrative matters relating to the Committee.
