ORDER

Subject: Constitution of an Assessment Committee for evaluating and empanelment of Government Agency for undertaking DDU-GKY Projects-reg.

The undersigned is directed to state that under Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDUGKY), a registered Project Implementing Agency (PIA) is eligible to be notified by Ministry as empanelled Government Agency for undertaking DDU-GKY projects on satisfaction of following conditions inter alia:

- a) should commit to skill 2000 candidates in first two years.
- b) alignment of courses with the National Skill Qualification Framework (NSQF) or National Council for Vocational Training (NCVT) or Sector Skill Councils (SSCs).
- c) should have a minimum capacity of concurrent training of 500 candidates in their own centers and geographical spread of the training centers including faculty / trainers.
- d) should have a minimum 50% placement track record during last three years with details of employer's tie-up.
- e) financial position during last three years to ensure training of minimum of 1000 candidates in a year.
- f) significance of the Government Agency in the chosen sectors of training / employment
- g) provide co-branded training centers and such Skill Training Centers will be named as "<Government Agency -DDU-GKY Skills Academy>" with co-branded training materials, Videos and PPTs.
- h) Should give placement to trained candidates with a minimum salary of Rs 8000 per month (CTC)

2. Accordingly, in order to evaluate and recommend the "Government Agency" for notifying as empanelled for undertaking DDU-GKY projects, the Ministry of Rural Development has constituted an Assessment Committee for the purpose. The members of this Committee will be as follows:


i.	Joint Secretary (Rural Skills)	Chairperson
ii.	Director (Skills)	Member
iii.	Head Program Management, DDUGKY	Members

iv.	Head Partnership Development	Member
v.	Representative of NIRD	Member
vi.	Representative of NABCON	Member
vii	Sector Expert (to be invited by Assessment Committee)	Member
viii	Under Secretary (Skill -I)	Member Secretary

3. The Assessment Committee shall decide based on the assessment parameters and recommend the Government Agencies for notifying as empanelled for undertaking DDU-GKY projects which may include taking a presentation by the PIA desirous to be notified. The Assessment Committee may invite experts / State Government representatives to advise the committee in its meeting.

4. The Assessment Committee shall be assisted by PfD, Rural Skills Division in all administrative matters relating to the Committee.
