1. Project Appraisal Committee on 10<sup>th</sup> July 2017 has reviewed the appraisal report submitted by NIRD & PR, working as appraisal agency for DDU-GKY & Roshni projects for SRLM Bihar, and submitted the recommendation to Project Approval Committee.



6. Project Approval Committee directed applicants to comply with the following instructions :

- i. The Project Approval Committee has directed all PIAs to setup required number of training centers within one month of signing of MoU.
- ii. All PIAs were directed to submit course content of all trades as per DDU-GKY guidelines printed in bilingual language to BRLPS within 15 days of signing of MoU.
- iii. It was directed to ensure availability of qualified trainers.
- iv. It was directed to take an affidavit regarding non blacklisting from PIA.
- v. PIA shall not sublet any of the training centers. If subcontracting is found to be adopted stringent action shall be initiated.
- vi. The first instalment of 25% will be released to PIA as per guidelines of DDU GKY. There is no requirement of bank guarantee for release of 1<sup>st</sup> instalment. This will also be applicable on 7 proposals approved by PAC dated 09<sup>th</sup> May 2017.
- vii. As requested by PIA Educator Extraordinaire Proposal code – DL2016CR1012120170316010709, (The proposal was approved by PAC in PAC meeting dated 9<sup>th</sup> May 2017) the PIA was granted permission to edit proposal through MRIGS. The proposal may be revised for trades and training centre location. The PIA's request to use Delhi as one of the training centre location is accepted by the PAC, as per the DDUGKY guidelines.

7. Keeping in view the huge target for state of Bihar for Annual Action Plan-2016-19, it was decided that the applications which have been recommended by NIRD & PR for other state may be invited with state specific proposal as per DDUGKY guidelines.











