ORDER

Blacklisting of M/s All India Asian Educational Foundation

Project Details:

- Sanction order No. 52 dated 13.04.2015
- Project duration and Target :- One year with training target of 1800 and placement target of 1350 candidates
- Total Project cost:- Rs.5,62,28,400/-
- MoU with M/s. All India Asian Educational Foundation on dated 13.04.2015
- Total amount released Rs.1,40,57,100/- (1st installment):- Rs.1,40,57,100/- vide Letter No.464 dated 28.07.2015
- Show cause notice issued because of poor performance vide letter No.1471 dated 16.03.2016.

Whereas M/s. All India Asian Educational Foundation had been sanctioned a project under DDU-GKY (Erstwhile Aajeevika Skills) for imparting placement linked training to rural youth of Odisha vide sanction letter No. 52 dated 13.04.2015.

In pursuance of the said sanction order, an MOU was signed on 13.04.2015 between ORMAS and the said Project Implementing Agency according to which PIA had to impart placement linked training to 1800 candidates within a period of 1 year. Total contract value for implementation of the project was Rs.5,62,28,400/- (Rupees Five Crore Sixty Two Lakhs Twenty Eight Thousand Four Hundred).

As per the sanction order M/s. All India Asian Educational Foundation received 25% advance amounting to Rs.1,40,57,100/- (One Crore Fourty Lakhs Fifty Seven Thousand One Hundred) only on 28.07.2015 out of total project cost of Rs.5,62,28,400/- (Rupees Five Crore Sixty Two Lakhs Twenty Eight Thousand Four Hundred) only.

The PIA has operated training in Odisha but due to poor performance a show cause notice bearing no 1471 dated 16th March 2016 has been issued to the PIA. Further a pre-closure letter vide letter no 2255 dated 27/09/2016 has been issued to the PIA. Again final closure notice has been issued 2605 dated 02/12/2016 to submit relevant training & placement documents as per the SoP

But on 19th Dec 2018 the PIA has claimed that they have submitted 353 candidates' placement documents and 28th Dec 2018 claimed that they have 620 candidates' training documents.

But after desk verification on 11/01/2019 it has been noticed that PIA has submitted 325 candidates training and placement documents and no one found to be placed as per norms of SoP. Same has been communicated to the PIA during the meeting held on 17th July 2019 in the presence of representative of PIA (Mr. Sunil Kumar Sahoo) and permission has been given to PIA to submit the corrected documents as per standards of SoP by 31st July 2019.

After due compliance by PIA and further desk verification it has been found out that no one is placed adhering to the standards prescribed in the SOP. Hence, a recovery letter has been issued to the PIA vide letter no 94 dated 10/01/2020 to recover Rs. 2,02,92,290/- (inclusive of penal interest @10% pa) from the PIA.

Again during the meeting with Mr. A. K. Srivastava, Chairman of All India Asian Educational Foundation on 12th March 2020 at ORMAS office, it has been instructed to the PIA to refund the entire amount along with penal interest otherwise legal action will be initiated.

As there was no response from the PIA side, a letter vide no 1642 dated 25/06/2020 has been issued to the PIA to recover Rs. 2,02,92,290/- for settlement and pre-closure of project. The letter has been returned back and again resent on 18th Aug 2020 through speed post, but till date there is no response received.

*Under the circumstances stated above, M/s. All India Asian Educational Foundation, 3 & 4 Institutional Area, Jasola, New Delhi-110025 bearing DDU-GKY PRN (Permanent Registration Number) DL2013RF1342 is being **Blacklisted** with immediate effect in the State of Odisha till further Order.*
