M/s Redox Labs, has committed serious/repeated default(s) under Section 10.2.3 of the Standard Operating Procedures, as per details provided below:

- 1) It has been noticed that Redox has not conducted courses, which is in alignment to NCVT or SSC and has not taken any steps in this regard. Also Redox has provided certificates to the students which is issued by M./s India Skills, a third party assessment agency. This is a major deviation with respect to the clause 3.2.2.2.6 (ii) of the DDU GKY guideline and clause No.4-II-4.2 (i) of MoU and is considered as MAJOR DEFAULT. This has been brought to your notice vide emails from DDU-GKY Kerala and your replies in this regard are not satisfactory.
- 2) AND WHEREAS Kudumbashree had send a major default notice on 30th may 2016 with respect to the Assessment and advised you to reply within 7 days of receipt of this alert for the deviation from MoU and DDU-GKY guidelines. As per SOP of DDU GKY, you have failed to submit any reply within the previously mentioned period.
- 3) AND WHEREAS Kudumbashree had send Second major default notice on 17th July 2016 with respect to the first major default notice and advised you to reply within 7 days of receipt of this alert for the deviation from MoU and DDU-GKY guidelines. As per SOP of DDU GKY, you have failed to submit any reply within the previously mentioned period.
