2. The NABCONS will be the designated Technical Support Agency (TSA) for coordinating and monitoring the project on behalf of the Uttar Pradesh Skill Development Mission.

3. The funds i.e. **Rs.4,65,32,027/-** shall be released as grant-in-aid to PIA through PFMS in four installments in the ratio of 25:50:15:10 subject to provisions of the DDU-GKY initiative under DDU-GKY Guidelines, July 2016, and Terms & Conditions specified in Standard Operating Procedure(SOP).

4. It is certified that there is no utilization certificate due from the Project Implementing Agency for any previous funds granted for this project by the Uttar Pradesh Skill Development Mission.

5. The proposal submitted by **M/s ALT TRAINING COLLEGE FOUNDATION** also forms an integral part of this Sanction Order. And the sanctions are as per the proposals submitted to Uttar Pradesh Skill Development Mission. Any deviation from the aforesaid proposal submitted to Uttar Pradesh Skill Development Mission, shall measure as violation of the directives issued in this sanction order.

6. The funds disbursed for the skill development project under DDU-GKY may be audited not only by Comptroller and Auditor General of India, but also by the Internal Audit or of the Principal Accounts functionary under Finance Controller of Accounts in the Uttar Pradesh Skill Development Mission as per orders issued by competent authority from time to time.

7. The PIA would be obligated to train at least 20% of the beneficiaries of the MNREGA LIFE Project during the duration of the project as mentioned above at serial no 1.7. The identification of the beneficiaries of MNREGA LIFE Project would be done by the

Department of Rural Development, Govt. of UP and their details would be provided by UPSDM

8. Monitoring Cost to the TSA(1.5% of Project Cost) will be in addition to the Project Cost given above at 1.
