Manipur State Rural Livelihoods Mission (MSRLM) invites proposal from interested Project Implementing Agencies (PIAs) to implement projects under Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDU-GKY) a placement linked skill development program by providing skill training to 4998 rural youths in the state of Manipur.

2. Manipur State Rural Livelihoods Mission (MSRLM), under the aegis of the Department of Rural Development and Panchayati Raj, Government of Manipur is the nodal agency to implement the program in the state of Manipur.

3. Interested agencies may submit their proposals online at [www.ruralskills.in](http://www.ruralskills.in) as per the format prescribed by MoRD along with the application fee of Rs. 25,000/- drawn in favor of "NABARD Consultancy Services Pvt. Ltd" Current Account no.: 000405015254, ICICI Bank Ltd, IFSC ICIC00000004, Branch address: Free Press House , 215 Nariman Point , Mumbai-400021.

4. Project duration should be of a maximum of three years. As per the targets available with the state at present, PIA should submit the proposal for a span of minimum 3, 6, 9 and 12 months and PIAs may apply, if they are willing to work/trained on the following sectors:

- i. Healthcare (Healthcare Service)
- ii. Handlooms & Handicrafts
- iii. Logistic Supply Chain Management
- iv. Electronics,
- v. Constructions,
- vi. Automative,
- vii. Green Skills,
- viii. Gems and Jewelry,
- ix. Food Processing and Sports,
- x. Banking, Financial Services and Insurance,
- xi. Electrical,
- xii. Furniture & Furnishings and
- xiii. Plastic Processing.



PIAs applying for sectors other than mentioned above shall be summarily rejected and will not consider for PAC at all.

5. Preference will be given to PIAs proposing for providing training to PWD targets specifically. For such PIAs, trades mentioned above are not applicable. They may propose to trained PWD targets in any trades, which are feasible and have higher employability in the market. While applying, PIAs should strictly adhere to the "Framework for DDU-GKY PWD Projects July, 2017" issued by Ministry of Rural Development, Government of India.

6. PIAs are requested to submit their proposals on or before 4<sup>th</sup> May, 2018. Proposals received after the scheduled date shall be considered on a later date subject to availability of funds and targets. Project Proposal submitted online only will be accepted by MSRLM.
