

Notice for inviting Project Proposals under Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDU-GKY) in the State of Karnataka

National Rural Livelihood Mission, MoRD, GoI is implementing placement linked skills development programme named Deen Dayal Upadhyaya Grammen Kaushalya Yojana (DDU-GKY) for which Sanjeevini - Karnataka State Rural Livelihood Promotion Society is the Nodal Agency to implement the programme in the State of Karnataka.

In view of simplification & streamlining of project application process, as per the notification 20/2017 dated 3rd April 2017 of MoRD GoI, Sanjeevini – KSRLPS invites proposal from registered Project Implementation Agency (PIA with valid PRN No.) with MoRD, Govt. Of India for the implementation of DDU-GKY Project in the State of Karnataka. Interested agencies may submit their proposals online at http://www.ruralskills.in/ along with application fee of Rs.25,000/- to be paid to the following bank account number.

Project appraisal fee would be payable separately to those projects which are recommended for qualitative appraisal in initial screening stage. The fee would be notified separately.

Submission of proposals is a continuous process & the cutoff date for this round of application would be 09.03.2018. The Proposals submitted on or before 09.03.2018, would be considered in this round & application received after aforesaid date shall be considered in next round of application subject to the availability of targets with the state. Incomplete proposal in any respect shall be summarily.

As per the targets available with the state at present (Total Targets available 68,454), the PIAs can submit the proposals for short term and long term duration courses (3,6,9 and 12 months).

PIAs are encouraged to apply for project approved by DDU-GKY. The lists of approved courses are available in DDU-GKY website (ddugky.gov.in).

The Priority order of the application will be decided on the basis of MoRD Notification no.20/2017 dated 3rd April 2017, however, PIAs who have applied as a "Captive Employer" or can proide "captive placement" (as defined in the DDU-GKY guidelines) would be given preference across the PIA categories, Preference will also be given to the PIAs who have experience in training & placement of PWD who wish to apply.

Government agencies may also apply for under taking DDU-GKY projects. Interested Government agencies may refer the Notification No.40, 2017 MoRD, GoI Dated: 24.07.2017 for more details.

The application process is completely online process hence there is no need to send the hard copy of documents. The entire process of application of proposals, screening & selection will be done strictly as per the guidelines & norms laid out by MoRD. Allotment of the districts may be done by Sanjeevini – KSRLPS based on the requirement/demand. While formulating the proposal, revised CNN (Cost Norms Notification) may be taken into account as per MoRD notification No.25, dated 4th May 2016.
