PIAs are requested to submit their proposals on or before **30th March, 2018**. Proposals received after the scheduled date shall be considered on a later date subject to availability of fund and target.

As per target assigned by the Ministry of Rural Development, preference will be given to PIAs with registered office and working experiences in the State of Sikkim.
