Project duration should be of a maximum of three years. As per the targets available with the state at present, PIA should submit the proposal for a span of 3 and 6 months.

PIA'S who have already submitted the project proposal may modify/resubmit the project as per this notification.

PIAs are requested to submit their proposal on or before **28th February 2019.**

Proposals received after the schedule date shall be considered on a later date subject to availability of fund and target.

As per target assigned by the Ministry of Rural Development, preference will be given to agencies providing captive placement and those PIAs with training centers in Mizoram. Incomplete proposal in any respect shall be summarily rejected.
