I am directed to convey the sanction of the President of India for the payment of grant-in-aid amounting to Rs.2,04,23,792/- (Rupees Two Crores Four Lakhs Twenty Three Thousand Seven Hundred and Ninety Two Only) to the NIRD, Hyderabad towards first installment of Central share of Monitoring & Evaluation cost for 11 projects approved for the State of Assam under Aajeevika Skills. The total cost of Monitoring & Evaluation is Rs.4,53,86,205- to be shared between Centre and State in the ratio of 90:10.
