The Empowered Committee of NRLM for DDU-GKY in its meeting held on 12th April 2021 had in principle approved the project under NRETP Saathi Haath Badhana – Establishment of a centralized call centre with dedicated number (toll free) with both inbound and outbound operation. The projects has been approved vide letter no. J-17024/01/2020DDU-GKY (370554) dated 06.07.2021. The duration of the project is 24 months with a total budgetary outlay of Rs.1,57,57,440.00. The first year demand is for an amount of Rs. 78,78, 720 (44,82,720+33,96,000). The Central Government shall release the funds for the project 25% of Rs. 78,78,720.00 as 1 tranche of 1st installment Rs. 19,69,680.00. The SRLM shall utilise the funds for fulfilling the targets as approved. MoRD will monitor and review progress of the project as per the timelines and output/outcomes given by the State.

7. This is the very first instalment for implementation of the above mentioned project. SRLM will implement REAT module under this project after receipt of this funds.


