5. Further, the NIRD shall also refund Rs 1,12,000.00 on account of interest earned by them to the Government of India in the form of Demand Draft to be issued in favour of Pay & Accounts Officer, Ministry of Rural Development, Govt. of India, Krishi Bhawan, New Delhi under intimation to this Ministry in respect of Special Project under SGSY implemented by the PIA(MGESSS) for placement linked Skill Development training of rural BPL youth in the States of Madhya Pradesh & Chhattisgarh(FileNo.F-J-17046/09/2011-SGSY-II(SP).

6. The NIRD shall release the funds within 15 days of the date of issue of this sanction order, after deducting monitoring charges @1.5% of total amount of 3rd and final installment released for the project. The NIRD shall send a compliance report after release of funds to the Ministry indicating that the funds have been released within 15 days.

7. It is certified that there is no utilization certificate due from NIRD/Manthan Gramin Evam Samaj Sewa Samiti for any previous funds granted for this project by the Ministry.
