The Empowered Committee of NRLM for DDU-GKY in its meeting held on 12th April 2021 has approved the project NRETP under DDU-GKY- Establishment of "Call Centre" an Alumni Support Helpline, for establishment and operationalization of the call centre on an outsourced model. The duration of the project is 24 months with a total budgetary outlay of Rs. 1,27,80,000.00. The SRLM shall utilise the funds for fulfilling the targets specified in the Minutes dated 8th June, 2021 of the Empowered Committee held on 12th April, 2021. MoRD will monitor and review progress of the project as per the timelines and output/outcomes given by the State.
